Message from the Section Chair

During the first half of 2019, the SRMS council has moved forward on several fronts intended to serve and benefit the section, and I greatly appreciate their efforts. While not wishing to short-change the efforts of any of the council, I highlight below some specific areas of interest to the section.

Due to the efforts of Asaph Young Chun (Program Chair) and Yang Cheng (Program Chair-elect), as well as to many of you, SRMS has put together another very strong program for the 2019 Joint Statistical Meetings in Denver, with 13 Invited sessions, 18 Topic Contributed sessions, 7 Contributed sessions, 4 Speed sessions, 2 Poster sessions, and 5 Roundtable discussions.

Thanks also to volunteer judges for poster and speed sessions and to session chairs. I think the meeting in Denver should be a real success for SRMS.

James Wagner (Education Chair) has organized an Oct 10 webinar and is working toward a second webinar. In addition, James has collaborated with Education Chairs for other sections to improve coordination and advertisement of webinars across the sections.

Steven Pedlow (Communications Officer) has kept the Section and ASA in general informed about SRMS activities and accomplishments through articles in Amstat News. Pushpal Mukophadhyay (Website Editor) uploaded 47 papers from the 2012 Hard to Reach Conference to the SRMS Proceedings page. Jamie Ridenhour and Julia Soulakova (Council or Sections Representatives) will be leading the section through its periodic charter review.

The section carried out its annual SRMS Student Travel Awards competition, receiving nine applications, from which three were given awards. In conjunction with GSS and SSS, SRMS also conducted its annual Student Paper competition, in which 32 submissions were received and five selected to present in a topic-contributed session at JSM. Thanks to the volunteers reviewing the submissions for both competitions.

In January, SRMS will be welcoming the new Officers who were elected this spring: Tony An (Chair-elect); Brady West (Program Chair-elect); and Gina Walejko (Secretary). The council looks forward to working with them in 2020. A huge thanks to all who ran for election, which is a critical part of our organization and requires members who are willing to offer their time.

As this will be my final column for the bi-annual SRMS Newsletter, I would like to take the opportunity to thank the entire SRMS council for their efforts this year, and in particular those who will finish their roles on the council at the end of 2019 – Karol Krotki, Asaph Young Chun, and Safaa Amer. Thank you very much for your service to the Section.

We hope to see you at the SRMS Business Meeting and Mixer on Wednesday July 31, 6-8 p.m. (Hyatt Regency – Centennial Ballroom A). There will be news of SRMS, award announcements, refreshments (cash bar and some free appetizers), and opportunities for socializing and networking.

I hope to see you at JSM 2019 and to have you involved in SRMS activities throughout the remainder of 2019 and beyond!

Report from the Treasurer

It has been a break-even year for SRMS finances. Some highlights of this past year (June 2018 – May 2019) include:

- Income:
 - Membership dues (~\$4600),
 - Seed funding return for BigSurv18 conference (\$6000) – BigSurv18 profit share is pending,
 - AAPOR sponsorship of 2018 JSM Business Meeting/Mixer (\$1000), and
 - Interest on our bank balance (~\$1200).
- Expenses:
 - JSM 2019 Student Travel Awards (~\$2500) and Student Paper Awards (~\$1600),
 - JSM 2018 Business Meeting/Mixer (~\$4500), and
 - *Journal of Survey Statistics and Methodology* subscription for members (~\$4200).

Altogether, we are roughly break-even for this time period. This is a good state of the treasury! Back in 2013 we were tasked with spending down our balance when SRMS received a combined \$40k profit share from sponsoring the 2012 H2R and 2012 ICES IV conferences. (Strategic) losses over the past 5 years have landed SRMS in the sweet spot of an account balance (\$40,700 as of June 14, 2019) between two to three times annual expenses (~\$20k in 2018 and ~\$15k in 2017). Finances in the past year keep SRMS on target to maintain this appropriate account balance.

Over the past 10 years, the biggest profit generators have been profit shares from conferences, registration fees (e.g. from webinars), and membership dues. The largest expenses have been awards (JSM travel, paper and poster awards), the JSM business meeting/mixer, and contributions to other organizations (e.g. seed funding of conferences of interest to section members). In the past 5 years of spending down our balance, the largest expenses have remained the same; however, the largest sources of income have been contributions from other organizations/sponsorships, interest on our bank balance, and membership dues. The SRMS Executive Committee is currently working to offer more webinars and continues to invest in conferences in an effort to maintain these important sources of income. We are always looking for sponsorship and educational opportunities to benefit our members!

SRMS is about 1,300 members strong, with member dues at \$8 – remember that \$3 of your dues goes towards your subscription to the *Journal of Survey Statistics and Methodology*. Thanks to all SRMS members for paying your dues!

One benefit for all members of the SRMS is that the *Journal of Survey Statistics and Methodology* (<https://academic.oup.com/jssam>) is provided to all Section members. This is a quarterly journal targeted to our Section as part of dues of \$8/year!

Our section provides free access to the Proceedings for the entire history of the Survey Research Methods Section (1978-2018), as well as the Proceedings from the Social Statistics Section (from which our section separated in 1978) from 1958-1977; and from all five International Conference on Establishment Surveys (ICES) meetings (1993-2016). Please note that some of these years are prior to the electronic proceedings available through ASA (2009-today); the section has scanned all earlier papers as a service to survey researchers. Each year SRMS gives awards to students to cover part of the costs of attending JSM. This year there were three recipients of this competitive award. Each applicant for this award submitted a short essay, a letter of recommendation from a faculty member, and college transcripts. A panel appointed by the SRMS Executive Committee selected the awardees based on the submitted materials. The 2019 panel consisted of Steven Pedlow (SRMS Publications Officer), Pushpal Mukhopadhyay, and myself.



JSM 2019 Update

I am delighted to report that the Survey Research Methods Section (SMRS) will have one of the most rigorous programs at the 2019 Joint Statistical Meetings. The JSM program of SRMS will feature a fine mix of sessions (co)sponsored by SRMS: 13 invited sessions; 18 topic-contributed sessions, seven contributed sessions, and three speed sessions. We also will have several roundtables that discuss recent methodological innovations.

I have organized an SRMS mission-enabling program that advances survey science, promotes evidence-based policymaking, and expands knowledge and real-world applications by the rigorous use of survey research methods. You will find several methodological papers discussing innovations under development. I have kept the promise I stated when running for the SRMS election in 2017.

The invited sessions of SRMS will attempt to provide solutions to the recent challenges of linked data, big data, and non-probability samples, while addressing the classical methodological issues of total survey errors, small area estimation, and multiple imputation. The topic-contributed sessions will be featuring sessions that highlight: 1) data integration, including the effective use of administrative records, big data, and non-probability samples; 2) the increasing use of responsive and adaptive design (RAD) in surveys; 3) methods to optimize data dissemination while preserving confidentiality; and 4) practical issues involving data science, cryptocurrency surveys, or propensity score methods. In addition, you are invited to participate in interactive speed sessions that will discuss a number of diverse methodological issues in survey research, such as sampling, data quality, nonresponse, integrating data from multiple sources, small area estimation, and methodological advancements.

You can tell we have a fair number of sessions competing to get your attention and requiring your advance planning! Therefore I would like to encourage you to prioritize the sessions you wish to attend by looking over the SRMS program below. Take advantage of the "My Program" feature that you may create online to tailor to your own interests.

SRMS-Sponsored Webinar: Multilevel Regression and Poststratification

Yajuan Si, a Research Assistant Professor in the Survey Methodology Program at the University of Michigan, will be offering a webinar on multilevel regression and poststratification (MRP) October 10, 2019 from 1-3pm. MRP is a method originally applied to political polls, but it has become increasingly popular with applications to demography, epidemiology, and many other areas. Adapted from hierarchical models, MRP is an approach to modeling survey or other nonrepresentative sample data that has the potential to adjust for complex design features and nonresponse bias while performing small area estimation. The seminar covers the statistical concepts and practical issues in implementing MRP with real-life application examples.


